Your Privacy is Important to us

This notice informs you how we use the information you give us and how we protect your privacy. It also explains your rights under the UK Data Protection Act (update 2018) and the EU General Data Protection Regulations 2018. We abide by UK Law and our data protection regulator within the UK is the Information Commissioners Office www.ico.org.uk

Collecting, Sharing and purpose for your information

We collect, store and process your personal information only for specific objectives. When you purchase products, enquire about our products, or provide us with your personal data we may collect personal data from you, such as your name, address details, your email address and a contact telephone number. We use your information to optimise our service, for example processing purchases and providing support. We offer payment services such as card payment options for our clients. To provide such a service, we may need to collect personal data such as name, address, contact details. Your information may be used to introduce you to the services we offer, to help with ongoing administration, to contact you with any review or changes that are applicable, for our own business research and analysis.

We may also disclose your personal data to our supply and delivery partners for the purpose of processing and fulfilling your order. Where such disclosures are made, this will be under contractual arrangements with us and carried out in accordance with the requirements of the Act. Some data processing is carried out on our behalf by a third party. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your personal data is treated securely and in accordance with this privacy policy.

We will not sell or share your information with any other third parties unless we have obtained additional consent from you.

Withholding of the required data may result in an insufficient service being provided. We may obtain data from individual customers or from employer firms.

Your rights regarding your data

- We will not hold your information for any longer than is necessary
- Should your data be inaccurate we will rectify this without delay
- Should you wish us to delete your data at any point, please contact the office as shown further below to make the request. This will be actioned unless there is a lawful basis for us to retain the information in which case you will be advised accordingly
- Should you wish to transfer your data to another organisation, please contact the office as below and we will organise this for you
- You can request access to your data at any time. We will provide you with a full copy within one month of your request
- You can withdraw consent to us holding and processing your information at any time.
 Please contact the office as below should you wish to do this
- We may provide you with updates and bulletins which are appropriate to your service on an ongoing basis this will be explained to you if it is applicable. You can opt out of these should you wish to contact us and advise us if you wish to.

Security

We have in place a full information security policy, business continuity and disaster recovery plans. We take data security very seriously and have in place we feel the most secure options available to store and transfer your data securely. We can provide details on request.

Cookies

We use cookies and Google Analytics to help us monitor how many people view each page and how they found our site. We can't see who you are or any of your personal details.

Cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.
